

# EURO LASERMASTER FRANCE LE PRADET 2017

Le Pradet du 8 au 10 Septembre 2017



## NOTICE OF RACE

The **Euro LaserMaster France Le Pradet** be held from **8 to 10 September 2017** in the Bay of the Garonne Le Pradet ( France ), organized by the Yacht Club of Pradet and the French Sailing Federation , together with the Laser class France and with the European Region of the international Association of Laser class ( EURILCA ) . This championship is part of the EURO 2017 MASTERS SERIES (EMS) coordinated by the European Region of the International Association of Laser class ( EURILCA )

### 1. RULES

The regatta will be governed by:

- 1.1 the rules as defined in *The Racing Rules of Sailing*, in as part of EURO MASTERS SERIES 2017 the EURILCA
- 1.2 National prescriptions for foreign competitors are defined in joined appendix named "prescriptions"
- 1.3 FFvoile regulations
- 1.4 In case of translation of this notice of race, the english text will take precedence.

### 2. ADVERTISING

In accordance with ISAF Regulation 20 (Advertising Code) as modified by the Advertising regulation of the FFVoile, boats may be required to display the advertising chosen and supplied by the organizing authority.

### 3. ELIGIBILITY AND ENTRY

- 3.1. The regatta is open to:
  - 3.1.1 - all boats from the class(es) Laser , Laser class rule 7 (a) is restricted as follows: Only one person shall be on board whilst racing. The regatta is strictly reserved for competitors born before 1 January 1983
- 3.2 Eligible boats may enter the site <http://www.cnpradet.com> filling out the form attached, and no later than 04/09/2017.
- 3.3 Registrations will be accepted out of time against a registration fee plus.
- 3.4 Competitors having a FFVoile licence accompanied with a medical certificate (dated less than one year) certifying the absence of any medical objection to participate in sailing competition shall present during registration:
  - if necessary a valid authorization to display advertising on boat
- 3.5 Foreign competitors without a FFVoile licence shall present during registration , a proof to be insured with a valid third-party liability insurance with a minimum cover of 1 500 000 Euros.

### 4. ENTRY FEES

- 4.1 The registration fee is € 80 for registration before 4/09/2017. After that date, they will be increased by 20 € ;so 100 €.
- 4.2 The meal on Saturday with entertainment is included in the registration. Accompanying persons may register it for a donation of € 25.

### 5. SCHEDULE

## APPENDIX “PRESCRIPTIONS”

### FFVoile Prescriptions to RRS 2013-2016 Applying to foreign competitors

**RRS 64.3 (\*)**:

The jury may ask the parties to the protest, prior to checking procedures, a deposit covering the cost of checking arising from a protest concerning class rules.

**RRS 67 (\*)**:

Any question about or request of damages arising from an incident involving a boat bound by the Racing Rules of Sailing or International Regulation to Prevent Collision at Sea depends on the appropriate courts and will not be dealt by the jury.

**RRS 70. 5 (\*)**:

In such circumstances, the written approval of the Fédération Française de Voile shall be received before publishing the notice of race and shall be posted on the official notice board during the event.

**RRS 78 (\*)**:

The boat's owner or other person in charge shall, under his sole responsibility, make sure moreover that his boat comply with the equipment and security rules required by the laws, by-laws and regulations of the Administration.

**RRS 86.3 (\*)**:

An organizing authority wishing to change a rule listed in RRS 86.1 in order to develop or test new rules shall first submit the changes to the FFVoile, in order to obtain its written approval and shall report the results to FFVoile after the event. Such authorization shall be mentioned in the notice of race and in the sailing instructions and shall be posted on the official notice board during the event.

**RRS 88 (\*)**:

Prescriptions of the FFVoile shall be neither changed nor deleted in the notice of race and sailing instructions, except for events for which an international jury has been appointed.

In such case, the prescriptions marked with an asterisk (\*) shall be neither changed nor deleted in the notice of race and sailing instructions. (The official translation of the prescriptions, downloadable on the FFVoile website [www.ffvoile.fr](http://www.ffvoile.fr) , shall be the only translation used to comply with RRS 90.2(b)).

**RRS 91 (\*)**:

The appointment of an international jury meeting the requirements of Appendix N is subject to prior written approval of the Fédération Française de Voile. Such notice of approval shall be posted on the official notice board during the event.
