

NOTICE OF RACE

- **1.1** The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS).
- **1.2** Rule defined by:

"Agreement for the organisation and execution of a Laser Euro Masters Series event in 2020."

- 1.3 In all rules governing this regatta: [NP] denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1(a).
- **1.4** If there is a conflict between languages the English text will take precedence. For the national prescriptions of the German Sailing Federation (DSV), the notice of race and the sailing instructions the German text will take precedence.
- **1.5** [DP] Competitors shall wear personal flotation devices at all times while afloat, except briefly while changing or adjusting clothing or personal equipment. This changes RRS 40.

2. [DP] Advertising

2.1 Boats may be required to display advertising and bow numbers chosen and supplied by the organizing authority.

3. [NP][DP] Eligibility and entry

- **3.1** The regatta is open to boats of the classes named under NoR 4.1 .
- **3.2** Eligible are sailors who are 35 of age or older.
- 3.3 We would like to highlight the following sentence of 1.2.:
 "During registration each sailor will be required to show clear written evidence of current membership of their national Laser Association. If a sailor is unable to present this, he/she will be charged a fee of 70€."
- **3.4** The person in charge shall provide either a valid licence of DSV, "Sportsegelschein" or a valid official licence prescribed or recommended for the racing area. Members of other national associations shall provide an equivalent licence issued by their national authority.
- **3.5** Each competitor shall be a member of a club affiliated to his national authority of World Sailing.
- **3.6** Eligible boats shall enter by completing the online entry form on the website Manage2sail until 03/09/2020 and paying the required fees. <u>https://www.manage2sail.com/de-DE/event/IDMa2020</u>

4. Fees

4.1 Required fees are as follows:

4.2 The entry fee shall be paid upon entering, even if the entry is cancelled later or the boat does not show up. The entry fee is non-refundable, except for the regatta or class being cancelled by the organizing authority or if the entry is rejected.

6. Schedule

6.1 Registration is scheduled as follows:

- 6.2 On the first scheduled racing day a skippers meeting will be held at 1030 hrs. Details will be published in the Sailing Instructions.
- 6.3 The schedule of races and dates of racing is as follows:

6.4 On the last day of racing, no warning signal will be made after 1400 hrs.

7. [NP][DP] Measurements

- 7.1 Each boat shall produce a valid measurement certificate.
- **7.2** Measurement checks may be carried out.. Detailed Information are given during registration and/or protest time.

8. Sailing Instructions

The sailing instructions will be available at registration and online.

9. Venue

- 9.1 The Events will be hosted in Greifswald Wieck.
- **9.2** The race office will be located in the club house of the Greifswalder Yachtclub (Yachtweg 4, 17493 Greifswald).
- **9.3** The racing area will be the Dänische Wieck and the Greifswalder Bodden.

10. Courses

The courses will be defined in the sailing instructions.

11. Scoring

- **11.1** Four races are required to be completed to constitute a championship.
- **11.2** When fewer than five races have been completed, a boat's series score will be the total of her race scores. When five or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

12. [NP][DP] Support Boats

- **12.1** All support boats shall be registered with the organizing authority and will be required to comply with local legislation and event Support Team Regulations. The organizing authority may refuse registrations and accept later registrations at their sole discretion.
- **12.2** Support persons shall wear personal flotation devices at all times while afloat, except briefly while changing or adjusting clothing or personal equipment. Support persons shall use the kill cord at all times when the engine is running.

- **12.3** Support boats shall be insured with valid and for the racing area suitable third-party liability insurance with a minimum cover of 1.500.000 EUR per incident or the equivalent.
- **12.5** Registration fees according to NoR 4.1.

13. [DP] Berthing

Boats shall be kept in their assigned places while they are in the boat park or harbour.

14. [DP] RADIO COMMUNICATION

Except in an emergency or when using equipment provided by the organizing authority, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

15. Prizes

- **15.1** Medals will be awarded to the first three places and certificates to the first six places by organizer.
- **15.2** The following titles will be awarded to the winners in each class: Internationale(r) Deutsche(r) Meister(in) of the:
 - age 35 to 44: Laser Standard Apprentice Master Laser Radial Apprentice Master (m/ f) Laser 4.7 Apprentice Master (Women only)
 - age 45 to 54 Laser: Standard Master Laser Radial Master (m/f) Laser 4.7 Master (Women only)
 - age 55 to 64
 Laser Standard Grand Master
 Laser Radial Grand Master (m/f)
 Laser 4.7 Grand Master (Women only)
 - age 65 to 74
 Laser Standard Great Grand Master
 Laser Radial Great Grand Master
 Laser 4.7 Great Grand Master (Women only)
 - age 75 and over
 Laser Radial Legend (m/f)

15.3 DSV awards championship prizes and titles only in classes/events sailing championships according to the notice of race.

16. [DP] Media rights, cameras and electronic equipment

- 16.1 Upon registration to the event competitors agree that photos and videos may be taken of their person and used as part the organizing authority's public relations activities, e.g. via websites, newsletters, print and tv media and social networks. In addition competitors or their guardians grant to the organizing authority without compensation the unlimited right to use images, photographs, television and radio material produced of them during the event.
- **16.2** Boats may be required to carry cameras, sound equipment and positioning equipment as specified and supplied by the organizing authority.
- **16.3** Competitors may be required to be available for interviews at the regatta.
- **16.4** Information about the competitors(name, club, placement) can be publicated by the hosting club.

17. Limitation of liability cognovits clause

- **17.1** The responsibility for the decision to participate in a race or to continue with it is solely with the skipper; to that extent the skipper also accepts full responsibility for the crew. The skipper is responsible for the qualification and the correct nautical conduct of the crew as well as for the suitability and the transport-safe-condition of the registered boat. In cases of force majeure or on grounds of administrative orders or for safety reasons, the organizer is entitled to make changes in the realization of the event or to cancel the event. This does not constitute any liability by the organizer towards the participant, if the reasons for the changes or the cancellation do not result from a willful or grossly negligent behaviour of the organizer. In case of a violation of obligations that do not constitute primary or material contractual duties (cardinal obligations), the liability of the organizer for financial and property damages incurred by the participant during or in connection with the participation in the event and resulting from a conduct of the organizer, its representatives, servants or agents, is restricted to damages that were caused willfully or grossly negligent. When a violation of cardinal obligations occurs due to minor negligence, the liability of the organizer is limited to foreseeable, typical damages. To the extent that the liability for damages of the organizer is excluded or restricted, the participant also relieves the staff - employees and representatives, agents, servants, sponsors and individuals who provide or drive salvage, safety or rescue vessels or assist with their use - from the individual liability for damages, as well as all other individuals who were instructed to act in connection with the realization of the event.
- **17.2** The effective racing rules of World Sailing, the administrative regulations regatta-sailing and the articles of association of DSV, the class rules as well as the regulations of the invitation to the competition and the sailing instructions are to be complied with and are expressly recognized.

- 17.3 The German law shall prevail.
- 17.4 Competitors shall present a signed and completed consent and declaration form at registration. For competitors under 18 years of age these forms shall be signed by a parent or guardian. The forms can be downloaded from manage2sail

18. [DP] Insurance

Each participating boat shall be insured with valid (and for the racing area suitable) third-party liability insurance with a minimum cover of 1.500.000 EUR per incident or the equivalent.

19. Privacy policy

The organizing authority will process and store personal data collected from entering and participating in the event. Addendum "Data Privacy Policy" gives relevant information and details.


3. Receive notifications

A5. Protection of data privacy

Reference is made to data protection of personal information and data. Any personal information and data given to the organizers will be used only as follows:

- All data regarding participating athletes, coaches and their boats will be processed and archived for the purpose of this sporting event.
- Personal information contains the participant's real name, date of birth, home club, boat type. boat number and address data. In particular, results, calculatory and visual analyses, position monitoring and race analyses will be published with reference to the competitors' names.
- In order to achieve this, the data will be transferred to our service providers such as manage2sail and to such governing bodies like World Sailing, Class Associations and DSV. It cannot be ruled out, that your data will be processed outside of the EU. Our service providers and governing bodies have been or will be committed by us, to exclusively use your data for the event and its preparation and post-processing, including ranking lists and global multi event scorecards.
- The commercial use of your data is prohibited.
- The use of your data is governed by German law, particularly by the German Data Protection Act (Datenschutzgesetz) and the German Telemedia Act (Telemediengesetz).
